 (READ BEFORE SIGNING)**

In consideration of being allowed to participate, in any way, in the Conejo Ski & Sports Club programs, related events, and activities I, \_\_\_\_\_ (Participant's Name Printed) the Undersigned, acknowledge, appreciate, and agree that:

1. The risk of injury from many of the activities is significant, including the potential for permanent paralysis and death, and while particular skills, rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
2. **I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES** or others and assume full responsibility for my participation; and,
3. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,
4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, **HEREBY RELEASE AND HOLD HARMLESS** Conejo Ski & Sports Club, their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used to conduct the event ("**RELEASEES**"), **WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, LOSS OR DAMAGE TO PERSON OR PROPERTY, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE**, to the fullest extent permitted by law.

Activity participant agrees that this release will apply to all known and unknown as well as unanticipated claims, injures and damages resulting from club activities, as well as, those now disclosed and all rights under section 1542 of the Civil Code of California are hereby expressly waived. Section 1542 of the Civil Code of California reads as follows:

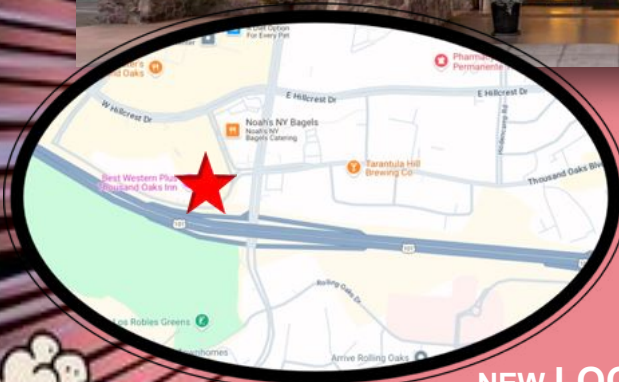
**"A general release does not extend to claims which the (person signing the release) does not know or suspect to exist in his (or her) favor, at the time of execution of the release, which if known by him (or her) must have materially affected his (or her) signing the release."**

In addition, I have read, understand and agree to the Conejo Ski & Sports Club (CSSC) Conduct Policy which states: *"All participants are required to observe common courtesy and generally accepted standards of behavior. CSSC will not tolerate violation of any federal, state, or local laws or ordinances. Illegal use of drug, tobacco or alcohol will cause the participant to be removed from the event. Additionally, CSSC will not reimburse the participant for any forfeited payments. CSSC may also choose, for the benefit of all participants, to prohibit smoking or alcohol at events. Participants who display obnoxious or offensive behavior in violation of this conduct policy, as determined by the CSSC event representative, may be removed and/or isolated from the group. Participants shall adhere to the requirements of the CSSC event packages (i.e. lift tickets) and not transfer, resell or barter all or portions of the package. Only CSSC or the issuing agency may compensate the participant for the unused portion or transfer. Failure to comply may result in exclusion from future CSSC sponsored activities."*

*CSSC maintains a strict policy prohibiting harassment or discrimination of any type. Additionally, if behavior offensive to others (profanity, off-color humor) continues after the offending person is asked by a CSSC representative to refrain from its use, the offending participant may be subject to sanctions up to removal from the activity and/or removal from the club."*

I have read and understand the above statements, and I am signing this document, granting this release and participating in this activity voluntarily. I also agree to abide by the CSSC conduct policy.

### **Proposed By-Laws Revision**

The Board reviewed and recommended these changes to allow us to address violations of our Conduct Policy in an efficient and effective manner. We have the best interest of our club members and their enjoyment of club events. Roslyn Hart, President

#### **EXISTING TEXT SEC. 5.5**

**5.5 Expulsion.** A member may be expelled for conduct which is harmful to members of the Club, which impairs the functioning of the Club, damages the reputation of the Club, or violates the Code of Conduct. If such conduct is brought to the Board's attention and a majority of the Board determines that expulsion of the member should be considered, the Board shall appoint a committee of three regular members who are not on the Board. The committee shall investigate and submit a written report to the Board stating the results of its investigation and its recommendation.

If expulsion or other disciplinary action shall be recommended, the Board shall schedule a hearing and give the accused member at least ten (10) day-notice thereof. The Board shall consider the committee's report, shall give the accused the opportunity to be heard, and may consider the statements of other persons present to the extent that they are relevant. Only Board Members present at the hearing may vote, and no member shall be expelled except by the vote of two-thirds (2/3) of a Board quorum; lesser discipline may be imposed by a Board majority vote. The Board shall advise the member at least 15 days prior to the effective date of the action taken.

A member whom the Board has voted to expel may appeal by giving written notice of appeal to the President and Secretary prior to the effective date of the expulsion. Within fourteen (14) calendar days after receiving such notice, the President or Secretary shall notify the Board of the appeal and shall furnish to the appealing member, and the Board, a list of past Presidents and past Board members who are then regular members of the Club, in good standing, and who are not currently serving on the Board (hereafter "Arbitrator List"). Within five (5) days of receipt of the Arbitrator list, the appealing member shall choose one person from the Arbitrator List and notify the Secretary of his or her choice. The Secretary shall notify the Board of the member's choice of Arbitrator, and within five (5) days the Board shall choose one person from the Arbitrator List and notify the Secretary of its choice of Arbitrator. The Secretary shall then notify the two Arbitrators who have been chosen of the pending disciplinary action, ensure the Arbitrators are willing to arbitrate the matter, and these two Arbitrators shall select a third Arbitrator from the Arbitrator List and ensure this person is also willing to arbitrate the matter.

The three Arbitrators shall comprise the Appellate Tribunal which shall promptly schedule a hearing, give notice of the hearing to the appealing member and the Board, conduct the hearing, determine whether or not the appealing member should be expelled, and notify the appealing member and the Board of its determination

#### **PROPOSED TEXT SEC. 5.5**

**5.5 Disciplinary Action.** A member may be disciplined for conduct which is harmful to members of the Club, which impairs the functioning of the Club, damages the reputation of the Club, or violates the Code of Conduct. When such conduct is brought to the attention of the Board, the Board shall investigate the conduct. After completion of the investigation, a supermajority (75%) of the Board may vote to impose consequences for the member up to and including termination of membership.

The Secretary shall then notify the two Arbitrators who have been chosen of the pending disciplinary action, ensure the Arbitrators are willing to arbitrate the matter, and these two Arbitrators shall select a third Arbitrator from the Arbitrator List and ensure this person is also willing to arbitrate the matter.

The three Arbitrators shall comprise the Appellate Tribunal which shall promptly schedule a hearing, give notice of the hearing to the appealing member and the Board, conduct the hearing, determine whether or not the appealing member should be expelled, and notify the appealing member and the Board of its determination.

### PROPOSED TEXT SEC. 5.5

**5.5 Disciplinary Action.** A member may be disciplined for conduct which is harmful to members of the Club, which impairs the functioning of the Club, damages the reputation of the Club, or violates the Code of Conduct. When such conduct is brought to the attention of the Board, the Board shall investigate the conduct. After completion of the investigation, a supermajority (75%) of the Board may vote to impose consequences for the member up to and including termination of membership.

1. Print a copy of this ballot from the newsletter or from the website. Place your completed ballot in a blank envelope (no name on the outside) and seal it. Place it in a 2<sup>nd</sup> envelope and address it to CSSC, P.O. Box 6276, Westlake Village, CA 91359. Your name and return address must be visible on the outside of the envelope. Be sure to write on the envelope "BALLOT."
2. Absentee Ballot must be received by Thursday, April 17<sup>th</sup> (the day of the elections). Your membership must be current 10 days prior to the day of the election, so if your membership is due, be sure to pay it at the first meeting of the month on April 3, 2025.

**This trip is for the physically fit and very active individuals.**



We start our adventure in the beautiful German town of Koblenz, which straddles the Rhine river and Moselle river. We will be taking a guided 3-hour walking tour of the old town to visit the Ehrenbreitstein fortress, the Munzplatz, the Liebfrauenkirche, the Basilica of St. Castor churches and the Kaiser Wilhein memorial. We will ride the Koblenz Cable Car, the largest aerial tramway in Germany, passing over the Rhine River between Konrad-Adenauer-Ufer and Greiffenklaustr on either side. We'll see incredible views and look out to the spot where the Moselle and Rhine rivers meet.

We then move on to the town of Cochem, where we will board the *Magnifique I*, our privately chartered boat and home for the next 7 nights. After a welcome meeting with the crew, our tour leaders will then take us for a walk through this cozy and characteristic town, exploring its steep



wine-clad mountains, wooded hills, an impressive castle and a picturesque square with beautiful timber-framed houses and cafes. We will visit Cochem's majestic Reichsburg Castle.

**Cochem to Zell** - Following breakfast, we cycle to Beilstein, one of the best-preserved historical villages on the Moselle. The ruins of the Castle Metternich sit towering above the village, and we'll have the opportunity to explore them. After leaving Beilstein we'll pass Europe's steepest vineyard – with slopes inclining up to 60 degrees – at Bremmer Calmont. Today's bike tour ends in the wine village of Zell on the Moselle.

**Zell - Bernkastel – Kues** Following breakfast, we cycle from Zell to the romantic village of Traben-Trarbach, located on the Moselle's left bank and famous for its Jugendstil (Art Nouveau) architecture. From there we pass through the wine city of Kröv – well known for its popular Kröver wine – to Bernkastel-Kues, our destination for the night. The grand half-timbered houses that surround Bernkastel-Kues's marketplace date back to the Middle Ages and are a photographer's delight. We reach the boat in Kues after a tour through town.

**Bernkastel - Kues - Neumagen - Schweich | Schweich - Trier** From Bernkastel, the valley opens up and vineyards expand as far as the eye can see. Today on our bikes we cruise past the heavy-hitters in the wine world: Brauneberg, Piesport, Trittenheim. Piesport is beloved by the Brits for the “little golden droplets. Trittenheim lies in a sharp hairpin turn on the river surrounded by mountains coated with grapes. Around lunchtime we will arrive in Neumagen and we can decide to join the boat from here or continue by bicycle to Schweich, where again the boat will be waiting for us. Once onboard, we will cruise to Trier, the oldest city in Germany which was founded around 15BC by Caesar Augustus under the name of Augusta Treverum. As a trading town and administrative center, Trier flourished during the late imperial age. This Roman golden age left us with a respectable number of monuments, one of the most authentic is the city gate Porta Nigra, which was built around 18AD.

**Trier - Saarburg.** In the morning our tour leaders will take us into Trier to learn about the Roman history. There is also time to discover and enjoy Trier on our own. After lunch, we will hop on our bicycles and follow the Moselle and Saar river to our next destination, Saarburg. Saarburg is an interesting old town situated in the most beautiful part of the Saar valley. Here, the banks of the river are densely forested. The castle of Saarburg was built here in the middle of the 10th century. In the middle of town, we will come across a waterfall 20 meters high. At the foot of this waterfall, there is an old mill, which is driven by the small river. In this part of town most of the old houses from the 17th and 18th century, which give Saarburg such a picturesque look, are still intact. Today there is no dinner on board. You can select one of the local restaurants of Saarburg for your evening dining.

**Saarburg - Remich** Today we have 2 cycling options. One is easy, but a bit longer along the rivers. The shorter option is a bit more challenging, through the hills. Whatever your choice is, the cycling will lead us into the Grand Duchy Luxembourg. Here the Moselle forms the border between Germany and Luxembourg. Luxembourg is a small country, but her capital is an important financial center and EU administrative city. On the way, at the Luxembourg side, we visit a wine cooperative, specialized in the so-called “Cremant”, the Champagne of the Moselle. Close to Remich we can admire a Roman mosaic floor. The tile floor which lies in its original place, was once the centerpiece

in a palatial Roman villa. The scene (in 3 million individual tile pieces) reveals scenes from gladiator games in the amphitheater.

**Remich - Schengen | Schengen - Thionville | Thionville - Metz** While having breakfast we will cruise to Schengen, where our cycling tour will start. The “Schengen agreement” is something everybody in Europe has heard of, whereas almost nobody knows that it is named after this little town in Luxembourg at the 3-country border. Soon we will cross the Luxembourg- French border and experience the outcome of this agreement: no border controls. We pass the fortress of Sierck-Les-Bains, one of the palaces inhabited by the powerful Dukes of Lorraine. The route is lovely through the French countryside, and friendly villages. Around lunchtime we will arrive in Thionville, the center of the steel industry until the 1980s. That might sound modern and industrial, but the city is ancient. The historic center shows us the medieval ramparts, lovely gardens, old streets, and St. Maximin Basilica. Here the boat is waiting to pick us up to cruise to Metz, another ancient city strategically situated on a Roman trading route. St. Etienne Cathedral is the 3rd largest gothic church in France with flying buttresses and Marc Chagall-stained glass windows. Metz is full of stunning architecture, flowers and great cafes.

After departing the boat, we will have a guided tour of the medieval town of Metz. We then hop the train to Reims (about an hour away to the west) where we will explore the Champagne region of France.

In Reims, our private tour guide will meet us at our hotel and take us on a 4.5-hour tour of Reims, including a visit to the Saint Remi Basilica (the Abbey), the Cathedral, and other notable sites. The next day is a free day in Reims. In the afternoon we will take the train to Paris, where we will spend the next 3 nights. Paris will be free time for everyone to do as they choose.

This trip includes 8 days and 7 nights rafting on the Colorado river through the Grand Canyon.

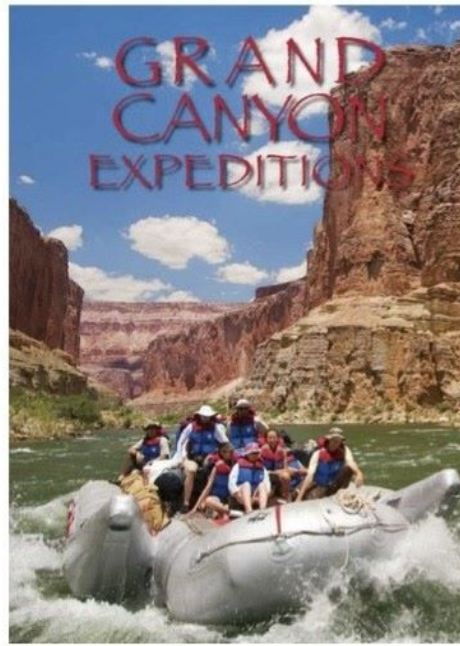
We will be traveling 277 miles on a motorized raft through the Grand Canyon negotiating 200 exciting white-water rapids in safety and first-class comfort.
